1. Call to Order/Roll Call

Committee Chair William Bourdeau called the meeting to order and roll was called. General Counsel Rebecca Akroyd confirmed that Board Alternate Justin Diener was participating via ZOOM for just cause, in compliance with Government Code section 54953.

2. The Water Resources Committee to Consider Additions or Corrections to the Agenda of Items, as authorized by Government Code Section 54950 et seq.

No additions or corrections.

3. Opportunity for Public Comment

No public comment.

4. Water Resources Committee to Consider Approval of the January 8, 2024 Meeting Minutes.

Chair William Bourdeau deemed the January 8, 2024 meeting minutes approved as submitted.

5. Delta Mendota Canal Subsidence Correction Project.

Executive Director Federico Barajas introduced Chris Park from CDM Smith. Park presented a PowerPoint presentation on the Delta Mendota Canal Subsidence Correction Project. Staff and Chris Park answered questions throughout the presentation.

6. Executive Director's Report.

- a. Delta Conveyance Project Executive Director Federico Barajas reported that Reclamation will not join the Department of Water Resources in State Water Resources Control Board change petition regarding Delta Conveyance Project.
- b. B.F. Sisk Dam Raise and Reservoir Expansion Project Executive Director Federico Barajas reported that Reclamation received approval from the Commissioner to move forward with negotiations, and there was a two-day session last week. Barajas reported that there are subsequent meetings scheduled and the Authority will continue to be engaged on behalf of Activity Agreement Members.
- c. O'Neill Pumping Plant (OPP) Outage Chief Operating Officer Pablo Arroyave reported that a 45-day outage at OPP is upcoming. Arroyave reported that staff has been coordinating with Reclamation and member agencies regarding the outage. Arroyave reported that there is a coordination meeting scheduled at the end of the month with Reclamation.

7. Update on Water Policy/Resources Activities.

Water Policy Director Scott Petersen provided a brief summary of the report included in the packet. Petersen reported that a copy of the Authority's comment letter on the Water Quality Control Plan Update Phase 2 Draft Staff Report is included in the packet. Petersen also provided updates regarding the Reinitiation of Consultation on Long-Term Operations of the CVP and SWP, Trinity River consultant, Water Quality Control Plan, San Joaquin Valley Blueprint, and the San Joaquin Valley Collaborative Action Program. Petersen answered Committee questions throughout the presentation.

8. Update on Water Operations and Forecasts.

Westlands Water District's Tom Boardman reported that Shasta storage surpassed 3.7 MAF and has increased its releases for flood control. The current refill rate is on pace to exceed Reclamation's median forecast. Folsom storage was also reported which included a projection on imminent releases for flood control and a brief mention of current snowpack conditions.

The contrast was made between the current rate between Delta outflow and exports. The controlling factor for recent export reductions was explained in addition to a near term projection of increased export that may be supported by expected increases in San Joaquin River flows.

San Luis reservoir storage was noted along with a brief report on refill projections that may

occur later this spring.

Boardman briefly responded to a question from a Director Bill Diedrich regarding the status of Trinity storage.
